**SELECTION OF DELEGATES**

Delegate registration must be submitted on the **Delegate Registration form and signed by the chair of the service body**. Delegates must also sign the delegate registration form in the appropriate box affirming they are in compliance with Subpart B, Article X, Section 3c) 1 of the OA, Inc. Bylaws.

A US\$149 registration fee is required for each delegate listed on the Delegate Registration form. US\$20 of the registration fee is non-refundable. Refunds will not be given on or after **April 1, 2021**. Payment is required in US funds.

Bylaws stipulate that delegates and alternates shall be registered seventy days prior to Conference. Therefore, the registration deadline is **February 8, 2021**.

*NOTE: Service bodies may register delegates after the February 8, 2021 deadline date, but Conference information will not be available to the delegate until properly registered with the World Service Office (WSO.)*

All delegates **MUST** register for the Conference with the WSO. Returning delegates are **NOT** registered automatically.

**WSBC PRIVACY POLICY**

**All delegates and alternates** must read, check the first box, and sign the WSBC Privacy Policy (attached to the Delegate Registration Form) to be formally registered for WSBC 2021.

**If you are an EEA (European Economic Area) resident, you must also consent to your data being transferred outside the EEA as described in the privacy policy by also checking the second box. You cannot be registered as a delegate without checking this box.**

**NEW BUSINESS MOTIONS AND BYLAW AMENDMENTS**

**December 10, 2020** is the postmarked deadline to submit New Business Motions or Amendments for OA, Inc. Bylaws.

Motions may be mailed or submitted through electronic transmission. If the submitted motion is postmarked or electronically date-stamped after December 10, 2020, it will **NOT** be considered.

When submitting Bylaw Amendments, you must 1) identify the bylaw section being amended, 2) list the current wording of the section, and 3) list the wording of the section as it would appear when amended.

If any other sections of the bylaws are affected by a proposed amendment, you are also responsible for proposing amendments to bring the other sections into compliance.

All proposed motions for new business or bylaws must include the name of your intergroup/service board and region, the name of the submitter, a contact phone number and email address, the intent of the motion, methods of implementation, primary purpose, and projected costs. New Business or Bylaw Amendment motions may include **up to one page of arguments** in favor of the motion.

The Bylaws Committee will aid service bodies in preparing New Business Motions or Bylaw Amendments. Write, fax, or email the committee in care of the World Service Office.

### ELECTION OF TRUSTEES

Trustees serve and represent Overeaters Anonymous as a whole, acting as guardians of the Twelve Steps, Twelve Traditions, and Twelve Concepts. They conduct, manage, and control the affairs and business of Overeaters Anonymous and serve as spokesmen in matters affecting OA as a whole. The role of a trustee, be it region or general service, is to furnish counsel and guidance to the members, groups, and service bodies; to supervise and guide education and attraction efforts of OA; and to perform such other duties as may be directed by the delegates at the Conference.

There are four region trustee positions open in 2021. They are from Regions Three, Six, Nine, and Virtual for three-year terms. Two general service trustee positions are open for three-year terms and one general service trustee position is open for a one-year term. Applications are due to the World Service Office by **January 19, 2021**.
